 - Bible-based event/ infallibility of the Bible
 - some interest in the Urantia Book Spiritual Vitamins
 - experienced some antagonism and a complaint about non-Biblical materials
 - asked to leave or display only Biblical materials chose to leave
 - good training/spirits not dampened/ will be forthcoming about Urantia Book in future

Tom suggested that outreach be to "unchurched" (10 million) rather than offend those who are happy with their faith choice. He also suggested that Thomas and Andrea come together to share ideas and plan a conference call one or two months before an event to process future plans and send them to the committee for input.
