

- (1) For many years it has been my practice to loan and/or give away copies of The Urantia Book.
- (2) Several years ago Urantia Foundation cut off sales to all distributors from whom book stores and other re-sellers traditionally obtain books. I was no longer able to obtain The Urantia Book from my traditional supplier, nor from book stores locally.
- (3) I learned that Urantia Foundation was selling small quantities of The Urantia Book directly to individuals, and in December, 1991 attempted to purchase copies directly from Urantia Foundation.
- (4) Urantia Foundation refused to sell me copies of The Urantia Book as evidenced by the attached copy of their January 3, 1992 letter sent to me by Certified Mail.

Affidavit

I declare under penalty of perjury the following to be true:

1. I recorded a complete audio version of the Urantia Book during the period 1981-1985 and have made it available without restriction for over 10 years. Because it has been distributed free of charge with no copying restrictions, I do not know how many copies currently exist, but my estimate, based on conversations with long-time readers from around the country, is that there must be several hundred copies in circulation. While no attempt was made either to advertise nor to hide the source of these tapes, it is generally known that the cassettes of the book in general circulation were recorded by me.

At least one of the current Urantia Foundation trustees, Richard Keeler, has had a copy of at least portions of the set for over 10 years, with full knowledge of the source of the tapes, and no attempt has ever been made by Mr. Keeler or Urantia Foundation to either contact me or to restrict the distribution of the tapes.

2. On this date, April 20, 1995, I attempted to order for immediate delivery a copy of the FolioViews index of the Urantia Book from Urantia Foundation and was told that it was currently unavailable (out of stock).



I, Eve C. McMahon declare, under penalty of perjury, that the following is true and correct to the best of my knowledge:

1. I reside at 2337 E. Gelding Drive, Phoenix, Arizona 85022-6114.
2. I have been a reader of The Urantia Book since November 1975.
3. I have introduced The Urantia Book to many people. In my experience, The Urantia Book is not widely available and is difficult to obtain. Whenever I tell a new reader how to get a book, it becomes a major event and seems to put a damper on a process that should be very quick and simple.
4. On or about Jan. 14, 1995 I tried to order by telephone from The Urantia Foundation a copy of its computer version of The Urantia Book. I was told that the computer version was not currently available because it was "out of stock." I left my credit card information with the Foundation and was told that I would be sent computer disks as soon as they were available, although no definite date was given.
5. On approximately February 28, 1995 I telephoned the Foundation to inquire as to why I had not received the computer disks. I was told that the Foundation still did not have any of these disks and could not give me a definite date as to when I might receive them. I then cancelled my order and decided to wait to order another time.
6. On April 26, 1995 I tried to place my re-order with the Urantia Foundation. I was again told that the disks were not yet available, and they could not give me a definite date as to when the disks would be available.
